



Pleasure Boats

Option I: Third Party Liability (against material damage and bodily injury)

Conditions:

- ✓ Warranted Marina based
- ✓ Warranted private pleasure use only
- ✓ Warranted manned licensed & professional skipper at all times
- ✓ Cruising limits: Lebanese territorial waters
- ✓ Premium is settled in Fresh USD only

Exclusion:

✓ Excluding loss or damage to insured boat

Option II: Institute Yacht Clause

Covers and Conditions:

- ✓ Covers losses/damages to hull, machinery, equipment, materials, engines, gear & everything connected therewith as per Institute Yacht Clause Cl.328 dated 1.11.1985
- ✓ Covers Third Party Liability up to boat's value (including passengers liability)
- ✓ Covers personal effects up to a certain limit (optional)
- ✓ Covers Machinery damage extension clause (due to boat's age)
- ✓ Warranted marina based
- ✓ Warranted private pleasure use only
- ✓ Warranted manned by licensed & professional skipper at all times
- ✓ Cruising limits: Lebanese territorial waters (for exceeding limits refer to Marine Dept.)
- ✓ Premium is settled in Fresh USD only

Deductibles:

✓ Deductible on Hull & Machinery claims to be applied
